I hereby request a reservation for the Mare named below to the stallion *CHICS IN THE MALE*, AQHA # 3021010 for the 20____season on the following terms:

1. I agree to pay a breeding fee of \$_____. 00 Plus GST (of which \$500. 00 plus GST is a non-refundable handling fee). This and all expenses shall be paid before the Mare leaves Sunglade Ranch Ltd. I understand that board up to 15 days and ONE ultrasound confirming pregnancy will be included in the stallion service fee in **the first year**. Subsequent mare care is \$12.00/day plus GST. Any additional veterinary fees will be billed directly. No Breeder’s Certificates will be issued until all charges are paid.
2. I represent and warrant that the Mare to be bred is **halter broken, healthy and in sound breeding condition**. The mare shall be left until settled during the season. I expect that you will use reasonable efforts to settle the Mare when present at Sunglade Ranch between the dates of March 1st 20____and July 1st 20____. Should I fail to deliver the mare for breeding on or before July 1st 20____ you shall be under no further obligation to this contract. Artificial insemination may be used in breeding my Mare.
3. Sunglade Ranch may exercise its own judgement in caring for and supervising the mare and/or foal. You and you veterinarian may perform at your absolute discretion such veterinary services as you deem necessary or appropriate at my expense. These include but are not limited to worming, treating for infections, disease or accident-related conditions, preventative measure, original examination or pregnancy checking.
4. Sunglade Ranch Ltd., the stallion owner, and any other parties involved shall be saved harmless of liability for any loss from fire, theft, sickness, disease, injury, death or other harm suffered by Mare and/or foal. Likewise I assume no liability for injury, sickness, or death of the stallion, owners or employees caused by my Mare and/or foal.
5. If the Mare does not settle or does not produce a “live Foal” (one that stands and sucks), I shall be entitled to return the Mare or a substitute for breeding the following year on the terms and conditions provided in the agreement without payment of any further breeding fee, but upon payment of board, handling fee and other expenses. It is agreed that this provision will be of no further effect if the Mare is taken to any other stallion before returning the above-named stallion **or does not produce a live foal after the second season**. If the stallion should die or become unfit for service before the terms of this contract are satisfied, the breeding fee, less the handling fee shall be refunded to me by stallion owner within a reasonable time of receipt by Sunglade Ranch Ltd. Of a veterinarian’s certificate stating the Mare is barren or did not produce a live foal.
6. A photocopy of the Mare’s papers showing both sides must be furnished and returned with this contract as one of the requirements.
7. When Sunglade Ranch Ltd. By it’s authorized representatives, signs and returns a copy of this off to me, it will become the binding contract of both parties. This contract is not transferable or assignable.
8. I agree to have my Mare current on vaccinations and worming and free of external parasites before delivery to Sunglade Ranch. I certify that my Mare has not had “strangles “ in the last 90 days before delivery to Sunglade Ranch. Should she develop this condition after the handling fee has been paid, I have the right to delay this agreement to the following season under the same terms and conditions as provided in the agreement.
